Question : In regard to investment promotion undertaken by Mainland Offices, what are the respective actual expenditure, revised and original estimates for years from 2006 to 2008?

Asked by : Hon. SIN Chung-kai

Reply :

A major role of the Mainland Offices is to promote Hong Kong's many advantages as a trade, investment and business hub in the region, and to attract Mainland enterprises to invest in Hong Kong. The Investment Promotion Divisions of the Mainland Offices will identify potential Mainland companies in the areas that they cover; proactively approach and visit the companies identified to encourage them to invest in Hong Kong; provide free, one-stop information and consultation services; and help identify and match Mainland potential investors with business partners in Hong Kong. As commercial relations and investment promotion activities all aim to project and market Hong Kong's strengths, they complement each other. General promotion work conducted by the Investment Promotion Divisions also supports the Mainland Offices' work on liaison and economic and trade affairs.

2. The Mainland Offices' investment promotion work is an integral part of their roles and functions on economic and trade affairs. The expenditure involved cannot be singled out and is absorbed within the provisions under Programme (3). The actual expenditure, revised and original estimates of the Mainland Offices on liaison, economic and trade, and investment promotion affairs under Programme (3) from 2006 to 2008 are as follow:

Question : It is noted that one of the aims of the Mainland Offices is to "represent and promote Hong Kong's trade and commercial interests in the Mainland".

1. What the Government has actually done last year to attain the above aim?
2. Which Mainland departments have been approached by the Government last year in a bid to represent and promote Hong Kong's trade and commercial interests? Which areas are involved?
3. Does the above work include the protection of legal rights of Hong Kong businessmen in the Mainland? If yes, what are the details?
4. What specific work will be taken by the Government to attain the above aim in the coming year?

Asked by : Hon. SIN Chung-kai

Reply :

One of the aims of the Mainland Offices in the economic and trade area is to represent and promote Hong Kong's trade and commercial interests in the Mainland. The Mainland Offices adopt a multi-pronged approach in taking this forward. They do so by organising trade missions, seminars and exhibitions for Hong Kong investors, as well as collecting and disseminating information on business information in the Mainland (including those relating to new laws and policies) to facilitate Hong Kong investors to understand the local business environment and establish their network in the Mainland. They also proactively approach Hong Kong investors and follow up issues of common concern through

appropriate channels. For example, in 2007, the Mainland Offices organised a series of seminars and workshops on areas of interest among the Hong Kong investors, including those on the Mainland and Hong Kong Closer Economic Partnership Arrangement, retail and commerce, financial services and new legislation and policies of the Mainland (such as the “Labour Contract Law” and processing trade policy). They also facilitated trade missions led by the Chief Executive to Jiangxi and Henan in January and April 2007, and trade missions to Hunan and Jiangxi led by the Secretary for Commerce and Economic Development in August and December 2007 etc.

2. The Mainland Offices also render assistance to Hong Kong residents who have met difficulties in the Mainland. In 2007, the Mainland Offices handled 51 cases relating to business and trade disputes, 66 cases relating to real estates complaints, and 153 cases relating to complaints against administrative, law enforcement and judicial agencies in the Mainland.

3. The relevant Mainland authorities which the Mainland Offices approach vary according to the nature of the work or individual case. For example, the Mainland Offices may approach the local Hong Kong and Macao Affairs Office on general liaison matters, the Commerce Department on commercial issues, and the Letters and Calls Department on complaint cases.

4. Looking forward, we will continue with the above efforts to represent and promote Hong Kong's trade and commercial interests in the Mainland in the coming year.

Question : How would the Government use the 2008-09 provision to promote Hong Kong's professional services in the Mainland, particularly those selected provinces, regions and municipalities directly under the Central Government, taking into consideration the potential for developing business opportunities between Hong Kong and the Mainland locations concerned and interests of the various sectors of the HKSAR? What is the expenditure in the respect?

Asked by : Hon. LEUNG Kwan-yuen, Andrew

Reply :

One of the aims of the Mainland Offices in the economic and trade area is to represent and promote Hong Kong's trade and commercial interests in the Mainland. The Mainland Offices adopt a multi-pronged approach in taking this forward. They do so by proactively approaching Hong Kong investors/practitioners in the places concerned and following up issues of common concern through appropriate channels; assisting Hong Kong investors/practitioners in obtaining information on business operation in the Mainland, particularly those relating to new laws and policies; and by assisting in arranging trade delegations to the Mainland etc.

2. As an integral part of the above work, opportunities will be taken in 2008-09 to incorporate the promotion of Hong Kong's professional services into the various activities to be launched by the Mainland Offices, including seminars, exhibitions, workshops and speeches as appropriate. The Mainland Offices will also explore opportunities to conduct activities targeted at the promotion of professional services matching the interests of the concerned professional sectors and the needs and circumstances of the selected provinces, regions and municipalities. Planned activities include seminars and workshops on Hong Kong's modern services (including those covered under the Mainland and Hong Kong Closer Economic Partnership Arrangement), and trade missions to selected Mainland provinces/municipalities etc. The Mainland Offices will maintain close contact with the relevant professional sectors in Hong Kong during the process.

3. In 2008-09, a sum of \$99.2 million has been earmarked under Programme (3) for the Mainland Offices to undertake liaison, economic and trade, and investment promotion work. The Mainland Offices' work in promoting Hong Kong's professional services in the Mainland is an integral part of the roles and functions of their work. The expenditure involved cannot be singled out and will be absorbed within the above provision of \$99.2 million.

Question : What are the specific work on publicity and educational activities
undertaken by the relevant authorities in 2007-08 and the expenditure involved?
What is the estimated provision for such activities in 2008-09?

Reply :

In 2007-08, the Equal Opportunities Commission (EOC) spent \$5.2 million
on publicity and training programmes. Major activities included :

- (i) media campaigns, including a television docu-drama series 2007
entitled "A Mission for Equal Opportunities", a radio programme
known as "Equal Opportunities Diversity Project" and an
announcement in the public interest on preventing pregnancy
discrimination;
- (ii) plays and puppet shows on equal opportunities, the three
anti-discrimination ordinances and diversity issues;
- (iii) a Career Challenge Mentorship Programme for secondary school
students;
- (iv) dissemination of educational materials and publications, including a
quarterly bilingual newsletter on EOC's work and case studies under
the anti-discrimination ordinances, 10th Anniversary Commemorative
Publication entitled "Advancing Equal Opportunities", online training
module on Preventing Sexual Harassment on Campus and provision of
information on equal opportunities through EOC's Online Resource
Centre;

- (v) provision of financial support to 54 community projects under the Community Participation Funding Programme for organising activities to promote equal opportunities; and
- (vi) organisation of over 280 training courses and talks for both public and private organizations.

The estimated provision for EOC's publicity and training programmes in 2008-09 is about \$5.4 million.

2. In 2007-08, the Privacy Commissioner for Personal Data (PCPD) incurred \$0.6 million on publicity and training programmes. Major activities included :

- (i) the Privacy Awareness Week 2007, a regional data privacy promotional event jointly launched with the privacy authorities of Australia and New Zealand;
- (ii) organisation of 12 seminars on "Introduction to the Personal Data (Privacy) Ordinance" for the general public and 66 seminars upon the request of organizations;
- (iii) organising workshops and experience sharing sessions for the Data Protection Officers' Club, a communication platform for data protection officers from both the public and private sectors;
- (iv) participation in the Education & Careers Expo 2008 with the objective of reminding job seekers of the need to protect their personal data; and
- (v) dissemination of publications, including PCPD's Annual Report, newsletters, guidance notes, information leaflets, consultation paper, etc.

PCPD plans to spend about \$1.95 million on publicity and educational activities in 2008-09.

Efforts made in this area include visits to host governments and trade organisations; cooperation with the above bodies in organising promotional, publicity and exchange activities; hosting activities to celebrate the 10th anniversary of the establishment of the HKSAR, assisting in visits of HKSARG senior officials and trade missions to the Mainland; and facilitating HKSARG's participation in various major events held in the Mainland. The opportunities were taken to establish closer ties and relations with the host and participating Mainland authorities and organisations.

2. In 2007-08, a sum of \$99.6 million has been earmarked under Programme (3) for the Mainland Offices to undertake liaison, economic and trade, and investment promotion work. Reply :

To enable Mainland residents to better understand Hong Kong and its latest developments, the Beijing Office sponsored three weekly radio programmes broadcast in different geographical areas for the purpose of reaching out to different target audiences. The programmes are “Beijing-Hong Kong Through Train”, “Tuning-in for Hong Kong” and “Exploring Hong Kong”.

2. “Beijing-Hong Kong Through Train”, co-produced with Voice of Huaxia channel of China National Radio since March 2001, covers southern China, including the Pearl River Delta region, Hong Kong and Macao. It is a half-hour programme broadcast mainly in Cantonese every Saturday. The programme covers various aspects about Hong Kong such as government policies, public services, the state of economy, culture and tourism. A rough estimate of the audienceship is 1.9 million each time when the programme is aired.

3. “Tuning-in for Hong Kong”, broadcast in Putonghua, is aired in nine provincial/municipal/autonomous regional radio stations in northern China, including Tianjin, Hebei, Henan, Inner Mongolia, Heilongjiang, Jilin, Liaoning, Shandong and Shanxi. The 10-minute programme, broadcast every Sunday, is co-produced with Voice of Huaxia channel of China National Radio starting September 2006. The content of the programme is wide ranging with the target audience being the public at large and the business sector. A rough estimate of the audienceship is over 9 million.

4. “Exploring Hong Kong” is a live programme broadcast in Putonghua throughout the Mainland every Friday. Co-produced with Voice of China channel of China National Radio since October 2006, the 10-minute programme is aimed at reaching out to the news conscious audience, as the programme is more news-oriented. A rough estimate of the audienceship is over 11 million.

5. The 2007-08 revised estimates for the three radio programmes is HK\$4.23 million. The 2008-09 estimates is HK\$4.5 million.

6. The audienceship data are provided by China National Radio, based on audienceship surveys conducted by them.

With the exception of Beijing Office and Guangdong ETO, the newly established Chengdu and Shanghai ETOs have operated for one year. Please provide information on the progress of work of the two new ETOs in respect of publicity for Hong Kong, promotion of trade between Hong Kong and Mainland, and assistance rendered to Hong Kong residents. Regarding the 2008-09 provision, which area of work has been allocated a larger portion of resources? In particular, how are they going to promote Hong Kong's professional services sectors in the Mainland?

Asked by: Hon. WONG Ting-kwong

Reply :

The Shanghai ETO and Chengdu ETO were both established in September 2006. In 2007, these two new Mainland offices had proactively pursued their objectives to represent and promote Hong Kong's trade and commercial interests in the Mainland and attract investments to Hong Kong.

2. At the initial stage of their operation, the two offices had endeavoured to establish working relationship with the local authorities and trade organisations through visits and various activities to celebrate the establishment of the offices etc. During the year, the two offices also organised a series of activities to celebrate the 10th anniversary of the establishment of the HKSAR and to showcase Hong Kong's various strengths and achievements. Opportunities were taken to integrate these activities with their work on economic and trade relations, and investment promotion to achieve synergy. Activities organised include roving exhibitions in 16 cities, cultural performances, film festivals, participation in local trade fairs, seminars on service industries, financial services etc.

3. The two new offices also spared no efforts in facilitating Hong Kong investors to tap into the business opportunities in the Mainland. They closely monitored major developments in the Mainland and assisted Hong Kong investors

in collecting information on business operation in the Mainland, such as that relating to the processing trade policy. They also facilitated/organized a number of business delegations and trade seminars. For example, the Shanghai ETO organised three trade missions to Jiangsu and Zhejiang between March and July 2007, and facilitated a 30-strong creative industries delegation led by the Secretary for Commerce and Economic Development to take part in the “2007 Shanghai International Creative Industry Week” held in Shanghai in November 2007. The Chengdu ETO organised a series of seminars on Hong Kong’s service industries and Chinese medicine and facilitated a trade mission to Hunan on processing trade led by the Secretary for Commerce and Economic Development in August 2007, and a trade mission to Nanchong of Sichuan on processing trade in October 2007.

4. On investment promotion, the Investment Promotion Divisions of the Mainland Offices proactively reached out to interested Mainland enterprises to invest in Hong Kong, and helped them go through the necessary procedures. In 2007, the two offices pursued 70 projects and completed 13. During the year, they also handled a total of 62 requests for assistance from the general public (other than those relating to immigration and personal safety matters).

5. For 2008-09, the Shanghai ETO and Chengdu ETO will be allocated \$23.7 million and \$16.5 million respectively for their operation. They will continue to step up their efforts in all the above areas in the coming year. As an integral part of the above work, opportunities will be taken to incorporate the promotion of Hong Kong’s professional services into the various activities to be organized. Planned activities include exhibitions, seminars and workshops on Hong Kong’s service industries, and trade missions to Mainland provinces/municipalities etc. The Shanghai ETO and Chengdu ETO will maintain close contact with the relevant professional sectors in Hong Kong during the process.

We plan to organise various activities under the overarching theme of how Hong Kong, with the successful implementation of the “One Country, Two Systems”, has and may continue to contribute to the reform and opening up of the Country.

2. In 2008-09, we are going to adopt a three-pronged approach as our strategy in promoting the Basic Law:

- firstly, we will use the electronic media as our key publicity channel to cover a wider range of the general public. We will introduce the more macro and concrete aspects of the Basic Law, including the constitutional set up of the “One Country, Two Systems” and the relationship between the Central People’s Government and the Hong Kong Special Administrative Region. Planned activities include TV documentary, radio game show and Announcement of Public Interests;

- secondly, we will enhance the public awareness and understanding of the Basic Law in a lively and interactive manner through promotional activities at the district level, such as roving exhibitions and variety shows; and
- thirdly, we will strengthen the co-operation with community organisations in organising promotional activities, in order to reach out the various sectors and groups through the different community networks.

Reply :

In 2007-08, we have allocated over \$3 million to sponsor community organisations in organising Basic Law promotional activities on a project-based basis. Sponsored bodies included the Joint Committee for the Promotion of the Basic Law of Hong Kong, the National Education Centre and the One Country Two Systems Research Institute Limited. All of them are active and major organisations in promoting the Basic Law among the youth sector, educational sector, professional sector and the general public.

2. To provide a steer on the overall programme and strategy for promoting the Basic Law both locally and overseas, the Government established in January 1998 the Basic Law Promotion Steering Committee (BLPSC), which is chaired by the Chief Secretary for Administration. All sponsorship items would be reported to the BLPSC. We would assess the proposals based on individual merits of the promotional plans, cost-effectiveness, creativity, etc. We would also take into account the organisations' past experience and reputation in organising similar activities. All sponsored bodies are required to prudently observe relevant internal guidelines and submit periodic financial reports for vetting purposes.

3. During the past five years, the Government as a whole has allocated over \$37 million (from 2003-04 to 2007-08) for the promotion of the Basic Law. Besides sponsoring community organisations in promoting the Basic Law, we have sought to enhance the public understanding over the fundamental principles in the Basic Law, e.g. "One Country, Two Systems", "Hong Kong people ruling Hong Kong" and a "high degree of autonomy" through a variety of channels in the past. For example, we have:

- produced various Announcement of Public Interests (APIs) introducing the concepts as contained in the Basic Law articles;
- made use of TV documentaries to introduce the historical background of the establishment of the HKSAR, the constitutional relationship between the Central People's Government and the HKSAR, as well as the successful implementation of the "One Country, Two System";
- organised quiz shows on TV and radio to promote understanding of the Basic Law in an interactive way;
- composed Basic Law theme songs and set up a Basic Law website to promote the Basic Law in a lively manner; and

- organised roving exhibitions at the district level and seminars by inviting renowned personalities as speakers with a view to presenting the content of and the in-depth concepts as enshrined in the Basic Law in an educational and informative manner. Promotional materials including leaflets were distributed.

Reply:

To prepare for the 2008 Legislative Council ("LegCo") Election, the Constitutional and Mainland Affairs Bureau ("CMAB") is working closely with the Electoral Affairs Commission ("EAC") on the necessary preparatory work, including the drafting of legislation relating to the election and review of various electoral arrangements. We are also co-ordinating Government-wide publicity efforts for the 2008 Voter Registration Campaign and the 2008 LegCo Election.

2. These tasks form an integral part of the Bureau's election-related policy work in 2008-09 and are carried out by the existing staffing establishment of the Bureau.

3. The EAC has the statutory responsibility for the conduct and supervision of elections. The Registration and Electoral Office ("REO") provides the EAC with the necessary support in conducting the 2008 LegCo Election. The costs for conducting the election will be met by the REO.

4. In 2004-05, the then Constitutional Affairs Bureau carried out preparatory work for the 2004 LegCo Election under similar arrangements.

In the circumstance, we do not have separate breakdown for expenditure on promotion measures for non-Chinese speaking people specifically.

2. As far as our promotion work is concerned, publicity and public education materials are normally published and disseminated in both Chinese and English. Where special support measures are implemented for the benefit of specific ethnic groups, the relevant materials are translated into the languages they use. For example, we distribute a service guidebook for ethnic minorities, which is published in eight languages, namely English, Indonesian, Tagalog, Thai, Sinhalese, Hindi, Nepali and Urdu. The guide to using the enquiries and complaints hotline operated by the Race Relations Unit is distributed in Chinese, English, Thai, Indonesian, Nepali and Urdu. We also sponsor weekly radio programmes for ethnic minorities, which are aired in Urdu, Nepali, and Bahasa Indonesia.

Reply :

The Constitutional and Mainland Affairs Bureau coordinates the government's liaison with Taiwan organisations in Hong Kong under the framework of the "One China" policy and "Qian's Seven Principles". In 2007-08, we continued to strengthen our liaison and relations with the Taiwanese business sector, trade associations, fraternity associations and other Taiwan organisations in Hong Kong. In addition, we supported exchanges between Hong Kong and Taiwan with a view to enhancing understanding of the latest development of Hong Kong and the implementation of "One Country, Two Systems" through, among other means, briefing relevant incoming Taiwan visitors.

2. In the past few years, we have proactively liaised with a wide spectrum of sectors in Taiwan. We have received members of the Taiwan legislature, including those from Pan-Blue and Pan-Green camps. We have received officials at the county and city levels of Taiwan, including delegations led by the Mayor of Taichung city, the Taipei city council and other public institutions. We have also organised visit programmes for Taiwan media representatives, professional bodies, businessmen, students and academia. These initiatives have been helpful in

enhancing understanding among different sectors in Taiwan on the implementation of “One Country, Two Systems” concept in Hong Kong.

3. In 2008-09, we will continue to co-ordinate liaison with Taiwan organisations in Hong Kong. Our major work will include –

(a) liaising with Taiwan organisations in Hong Kong on matters concerning the relations between Hong Kong and Taiwan;

(b) advising and assisting other bureaux and departments on cultural, trade and economic exchanges with Taiwan; and

We are also co-ordinating Government-wide publicity efforts for the 2008 Voter Registration Campaign and the 2008 LegCo Election.

2. These tasks form an integral part of the Bureau’s election-related policy work and are carried out by the existing staffing establishment of the Bureau.

3. The EAC has the statutory responsibility for the conduct and supervision of elections. The Registration and Electoral Office (“REO”) provides the EAC with the necessary support in conducting the 2008 LegCo Election. The costs for conducting the election will be met by the REO.

Question: Despite the growing Mainland-Hong Kong trade and commercial ties, the increase in the financial provision for Mainland Offices under Programme (3) is only 1.2%, which is disproportionately smaller than the 100% and 50% increases for those of the Director of Bureau's Office and Programme (2) respectively. What are the reasons?

Reply :

The financial provision for 2008-09 under Programme (1) is \$5.6 million higher than the revised estimate of \$5.3 million for 2007-08, representing an increase of 105.7%. It is mainly due to the increased provisions for salary and general departmental expenses arising from the creation of one position each of Under Secretary and Political Assistant as well as a post of Senior Personal Secretary.

2. For Programme (2), the provision for 2008-09 is \$78 million, which is 55.4% higher than the revised estimate for 2007-08 of \$50.2 million. It is mainly due to the increased provisions for enhancing promotion of the Basic Law, preparing the HKSAR's participation in the Expo Shanghai 2010, complementing the Nation's 12th Five-Year Plan, conducting public consultation on the two electoral methods for 2012 and creation of new posts to strengthen support for these initiatives.

3. With regard to Programme (3), the Mainland Offices had been given additional resources in 2007-08 to organise a series of events to celebrate the 10th anniversary of the establishment of the HKSAR. In 2008-09, the allocation for the Mainland Offices is \$120 million, representing an increase of 1.2% as compared with the 2007-08 revised estimate of \$118.6 million. If we exclude the one-off funding for the 10th anniversary celebration events (\$8.465 million) from the 2007-08 revised estimate, the increase in 2008-09 will in fact be 9%. Furthermore, it should be noted that the increased provision under Programme (2) in respect of the HKSAR's participation in the Expo Shanghai 2010 and complementing the Nation's 12th Five-Year Plan will also enhance our work in the Mainland Affairs.

Reply :

One of the aims of the Mainland Offices in the economic and trade area is to represent and promote Hong Kong's trade and commercial interests in the Mainland. The Mainland Offices adopt a multi-pronged approach in taking this forward. They do so by proactively approaching Hong Kong investors/practitioners in the places concerned and following up issues of common concern through appropriate channels; assisting Hong Kong investors/practitioners in obtaining information on business operation in the Mainland, particularly those relating to new laws and policies; and by assisting in arranging trade delegations to the Mainland etc.

2. As an integral part of the above work, opportunities will be taken in 2008-09 to incorporate the promotion of Hong Kong's professional services into the various activities to be launched by the Mainland Offices, including seminars, exhibitions, workshops and speeches as appropriate. The Mainland Offices will also explore opportunities to conduct activities targeted at the promotion of professional services matching the interests of the concerned professional sectors and the needs and circumstances of the selected provinces, regions and municipalities. Planned activities include seminars and workshops on Hong Kong's modern services (including those covered under the Mainland and Hong Kong Closer Economic Partnership Arrangement), and trade missions to selected Mainland provinces/municipalities etc. The Mainland Offices will maintain close contact with the relevant professional sectors in Hong Kong during the process.

3. In 2008-09, a sum of \$99.2 million has been earmarked under Programme (3) for the Mainland Offices to undertake liaison, economic and trade, and investment promotion work. The Mainland Offices' work in promoting Hong Kong's professional services in the Mainland is an integral part of the roles and functions of their work. The expenditure involved cannot be singled out and will be absorbed within the above provision of \$99.2 million.

Reply :

The Government of Hong Kong Special Administrative Region (HKSAR) has all along attached importance to the co-operation relationship with Guangdong Province and Macao. The Governments of HKSAR and the Guangdong Province have jointly set up the Hong Kong/Guangdong Co-operation Joint Conference in 1998 to actively press ahead co-operation in all aspects.

2. The Governments of HKSAR and the Macao Special Administrative Region have also reached a consensus to further enhance co-operation and to establish liaison officer mechanism, in order to facilitate direct communication and exchanges between the corresponding departments of both sides, and to actively take forward the co-operation items.

3. The Chief Executive of HKSAR and the Party Secretary of Guangdong Province met in January and March 2008, to discuss further enhancement of Hong Kong/Guangdong co-operation. The Party Secretary indicated that Guangdong would wish to strengthen all aspects of Hong Kong/Guangdong co-operation with an innovative approach. The Guangdong Province has commenced studies on this issue. The relevant departments of the Government of HKSAR actively support the studies with a view to raising the level of Hong Kong/Guangdong co-operation and further achieving a “win-win” situation.

4. We have established the Mainland Affairs Liaison Office to take forward, amongst other issues, Hong Kong/Guangdong co-operation. Our Economic and Trade Office in Guangdong also covers this work.

5. In 2008-09, the Constitutional and Mainland Affairs Bureau has allocated around \$1.4 million as departmental expenses for covering such expenditure in the co-operation activities with Guangdong and Macao.

Reply :

The Constitutional and Mainland Affairs Bureau coordinates the government's liaison with Taiwan organisations in Hong Kong under the framework of the "One China" policy and "Qian's Seven Principles". In 2007-08, we continued to strengthen our liaison and relations with the Taiwanese business sector, trade associations, fraternity associations and other Taiwan organisations in Hong Kong. In addition, we supported exchanges between Hong Kong and Taiwan with a view to enhancing understanding of the latest developments of Hong Kong and the implementation of "One Country, Two Systems" through, among other means, briefing relevant incoming Taiwan visitors.

2. These activities have helped to promote ties and exchanges between Hong Kong and Taiwan. For instance –

- (a) we have proactively liaised with a wide spectrum of sectors in Taiwan in the past few years. We have received members of the

Taiwan legislature, including those from Pan-Blue and Pan-Green camps. We have received officials at the county and city levels of Taiwan, including delegations led by the Mayor of Taichung city, the Taipei city council and other public institutions. We have also organised visit programmes for Taiwan media representatives, professional bodies, businessmen, students and academia. These initiatives have been helpful in enhancing understanding among different sectors in Taiwan on the successful implementation of “One Country, Two Systems” in Hong Kong.

- (b) we have maintained liaison with Taiwan organisations in Hong Kong. This helps to promote mutual understanding and exchange; and
- (c) we have liaised with relevant Taiwan organizations in Hong Kong to handle specific matters smoothly, such as exchanges of information on food safety.

3. In 2008-09, we will continue to co-ordinate liaison with Taiwan organisations in Hong Kong. Our major work will include –

- (a) liaising with Taiwan organisations in Hong Kong on matters concerning the relations between Hong Kong and Taiwan;
- (d) advising and assisting other bureaux and departments on cultural, trade and economic exchanges with Taiwan; and
- (e) promoting exchanges between Hong Kong and Taiwan and facilitating relevant Taiwan visitors to understand the latest developments of Hong Kong and the implementation of “One Country, Two Systems”.

Reply :

The manning of the enquiry and complaints hotline is part of duties of the Race Relations Unit (RRU) which is responsible for organising activities and support services to promote racial harmony. We do not maintain a separate breakdown of the cost involved in handling the enquiries and complaints.

2. Of the 402 cases handled by the RRU in 2007, 387 were enquiries on the activities organised by the Unit and for information on public services. The remaining 15 were complaints alleging racial discrimination. Except for two complaint cases which are being processed, all the other 400 cases have been addressed and settled.

3. Under the Race Discrimination Bill, the Equal Opportunities Commission (EOC) will have responsibility for implementing the new legislation when enacted and for promoting equal opportunities and racial harmony. The Government has set aside funding of \$6 million for preparatory work in anticipation of the passage of Bill. After enactment of the new ordinance, additional recurrent resources will be provided to EOC for it to perform its statutory functions. The amount of

recurrent funding to the EOC, which is to be transferred from within CMAB’s envelop, will be separately assessed.

Reply :

In 2008-09, the estimated provision for implementation of educational measures to promote awareness of racial harmony and equality is about \$2.8 million.

2. In addition, there is financial provision in respect of other support services for ethnic minorities, for example, community support and development teams, language training classes, cross-cultural youth programmes, mobile information service at the airport and special radio programmes for ethnic minorities.

3. As far as our promotion work is concerned, publicity and public education materials are normally published and disseminated in both Chinese and English. Where special support measures are implemented for the benefit of specific ethnic groups, the relevant materials are translated into the languages of the target groups. For example, we distribute a service guidebook for ethnic minorities, which is published in eight languages, namely English, Indonesian, Tagalog, Thai, Sinhalese, Hindi, Nepali and Urdu. The guide to using the enquiries and complaints hotline operated by the Race Relations Unit is distributed in Chinese, English, Thai, Indonesian, Nepali and Urdu. We also sponsor weekly radio programmes for ethnic minorities, which are aired in Urdu, Nepali, and Bahasa Indonesia.

We do not have separate statistics on the staffing and expenditure involved.

2. Prior to the introduction of the Race Discrimination Bill into the Legislative Council, the Government conducted an extensive public consultation from September 2004 to February 2005. From that consultation exercise, we received 240 written submissions from different sectors of the community. Government officials also attended 67 meetings, seminars, forums and briefings with different groups and organisations during the consultation period. The consultations covered different ethnic minority groups.

Of this amount, \$8.7 million was spent on sponsoring non-governmental and private organisations in promoting racial harmony and equality, children's rights and equal opportunities for people of different sexual orientation.

2. In 2008-09, the total expenditure on public education and promoting the rights of the individual, excluding personal emoluments, is estimated to be \$13.7 million.

2. The Second Report of the HKSAR under the International Covenant on Economic, Social and Cultural Rights was submitted as part of China's First Report to the United Nations (UN) in June 2003. The UN hearing, held on 27-29 April 2005 at the UN Office in Geneva, was attended by one Administrative Officer Staff Grade A1 (AOSGA1)(Acting), one Administrative Officer Staff Grade C (AOSGC), one Senior Administrative Officer (SAO) and one Principal Information Officer (PIO), one Law Officer (LO) and one Government Counsel (GC). The expenditure for their attendance was \$176,476. There were also representatives from the then Health, Welfare and Food Bureau (HWFB), Social Welfare Department, Labour Department, and Housing Department, whose attendance were funded separately by their respective bureaux.

3. The First Report of the HKSAR under the Convention on the Rights of the Child was submitted as part of China's Second Report to the UN in June 2003. The UN hearing, held on 19-20 September 2005 at the UN Office in Geneva, was attended by one Administrative Officer Staff Grade B1, one SAO, one PIO, one Deputy Law Officer and one Senior Government Counsel. The expenditure for their attendance was \$94,827. There were also representatives from the then Education and Manpower Bureau and HWFB, whose attendance were funded separately by their respective bureaux.

4. The Second Report of the HKSAR in the light of the International Covenant on Civil and Political Rights was submitted to the UN in January 2005. The UN hearing, held on 20-21 March 2006 at the UN headquarters in New York, was attended by one AOSGA1, one AOSGC, one SAO, one PIO, one LO and one GC. The expenditure for their attendance was \$221,113. There were also representatives from the then Constitutional Affairs Bureau and Security Bureau, whose attendance were funded separately by their respective bureaux.

5. The Second Report of the HKSAR under the Convention Against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment was submitted as part of China's Fourth and Fifth Combined Reports to the UN in June 2006. We are given to understand that the UN hearing will likely be held in November 2008 at the UN Office in Geneva. We have earmarked \$332,000 in 2008-09 to cover the expenses for attendance.

6. The Second Report of the HKSAR under the International Convention on the Elimination of All Forms of Racial Discrimination will be submitted as part of China's Tenth to Thirteenth Combined Reports shortly within 2008. The date and venue of hearing has yet to be scheduled by the UN.

Reply :

Since the Reunification, we have been promoting the Basic Law through civic education, school education and training for civil servants. The Constitutional and Mainland Affairs Bureau (CMAB) is the policy bureau responsible for coordinating the promotional efforts, with Home Affairs Bureau, Education Bureau and Civil Service Bureau etc. organising related promotional activities in their respective sectors within their own budget. Apart from the organisation of sectoral promotional activities by relevant bureaux, we have also allocated resources for sponsoring community organisations in organising Basic Law promotional activities on a project by project basis.

2. To provide a steer on the overall programme and strategy for promoting the Basic Law both locally and overseas, the Government established in January 1998 the Basic Law Promotion Steering Committee (BLPSC), which is chaired by the Chief Secretary for Administration. All government promotional activities and sponsorship items would be reported to the BLPSC. We would assess the sponsorship proposals based on individual merits of the promotional plans,

cost-effectiveness and creativity etc. We would also take into account the organisations' past experience and reputation in organising similar activities. All sponsored bodies are required to prudently observe relevant internal guidelines and submit periodic financial reports for vetting purposes.

As a result, the key performance indicators for Mainland Offices in 2008 are standardised to cover the work of all the four HKSAR Offices in the Mainland, including that of the Beijing Office. The performance indicators for 2007 only include those of the Guangdong, Shanghai and Chengdu ETOs, as the work of the Beijing Office then were reported in a different format under Head 35.

2. In 2008-09, the allocation for the Mainland Offices under Programme (3) is \$120 million, representing an increase of 1.2% as compared with the 2007-08 revised estimates. We have earmarked \$45.8 million for the Beijing Office, \$34.0 million for the Guangdong ETO, \$23.7 million for the Shanghai ETO, and \$16.5 million for the Chengdu ETO. The Mainland Offices will adopt a multi-pronged approach and flexibly deploy their resources to take forward their work in the coming year.

The on-going administrative and educational measures to promote public awareness of racial harmony and equality will include operation of the enquiry and complaints hotline, funding of promotional projects under the Equal Opportunities (Race) Funding Scheme, school talks and briefings for non-governmental organisations, distribution of information material and teaching kits, as well as the organisation of exhibition to foster public understanding and appreciation of ethnic minority cultures.

2. The total expenditure involved for these public awareness promotion measures in 2008-09 is estimated to be \$2.8 million.

3. In addition, we will continue to undertake measures to provide support services for ethnic minorities, for example, community support and development teams, language training classes, cross-cultural youth programmes, mobile information service at the airport and special radio programmes for ethnic minorities. We have also earmarked \$16 million as the operating expenses and \$8 million for subsidising the start up cost for four support service centres for ethnic minorities in 2008-09 which will provide, on a trial basis, interpretation service, language courses and other community integration programmes for ethnic minorities.

How did the ETOs handle these cases and what were the resources involved? Please provide a breakdown by causes of the percentage of the cases resolved successfully?

Reply :

Immigration Divisions are set up under the Beijing Office (BJO) and Guangdong Economic and Trade Office (GDETO) and are tasked, among other duties, to provide practicable assistance to Hong Kong residents in distress. There are five Immigration Officer posts in BJO (supported by five local staff) and four in GDETO (supported by one local staff). For 2007-2008, the revised estimate for the Immigration Divisions of BJO and GDETO is \$12.1 million and \$6.6 million respectively.

2. Assistance rendered by the Immigration Divisions of BJO and GDETO usually covers the following scenarios:

- (a) **Loss of travel documents or monies:** Verifying the identity of the concerned Hong Kong residents who have lost their travel documents and facilitating their early return to Hong Kong. The Divisions will also contact the family of the concerned Hong Kong residents where necessary. There were 84 such cases for BJO and 5 cases for GDETO in 2007.
- (b) **Accidents, injuries and decease cases:** Providing practicable assistance to the concerned assistance seekers and their families, including:
 - (i) notifying, as soon as possible, relatives of the parties concerned;

- (ii) contacting family/travel agencies to arrange for the early return of the injured persons to Hong Kong for treatment;
- (iii) facilitating the entry of the injured persons at control points back to Hong Kong;
- (iv) if medical treatment is required in the Mainland, and where practicable, providing information on medical services available for reference; and
- (v) assisting family members of the deceased in completing the application procedures for death certificates and for transporting the bodies back to Hong Kong.

There were 122 such cases for BJO and 107 cases for GDETO in 2007.

- (c) **Arrest or Detention:** The Divisions will gather details of the case from the assistance seekers (usually family members of the concerned Hong Kong resident) and explain to them the relevant Mainland laws, regulations and procedures for criminal cases under different stages of investigation, prosecution, trial or imprisonment, etc. They will also advise the assistance seekers that they may appoint Mainland lawyers as their legal representatives. Where required, the Divisions can provide the assistance seekers with the relevant contact details of law societies in the concerned provinces/region under its coverage, so that the assistance seekers may consider seeking appropriate legal representation. At the request of the assistance seekers, the Divisions will pass on and reflect their views and requests to the relevant Mainland authorities and provide them with relevant information for reference (e.g. the rights and obligations of a person under detention) according to the development of the case. There were 28 such cases for BJO and 37 cases for GDETO in 2007.

3. Some of the cases involved follow-up actions over a period of time. As the nature of the cases varies, it is not practicable to compile a success rate. The Immigration Divisions of both BJO and GDETO will diligently attend to each case and provide timely and practicable assistance and follow up as appropriate.

With a view to further enhancing public understanding of the Basic Law, the Constitutional and Mainland Affairs Bureau has earmarked \$16 million in 2008-09 for promoting the Basic Law. We plan to organise various activities under the overarching theme of how Hong Kong, with the successful implementation of the “One Country, Two Systems”, has and may continue to contribute to the reform and opening up of the Country.

2. In 2008-09, we are going to adopt a three-pronged approach as our strategy in promoting the Basic Law:

- firstly, we will use the electronic media as our key publicity channel to the general public. We will introduce the more macro and concrete aspects of the Basic Law to the general public, including the principle of the “One Country, Two Systems” and the relationship between the Central People’s Government and the Hong Kong Special Administrative Region. Planned activities include TV documentary, radio game show and Announcement of Public Interests;

- secondly, we will enhance the public awareness and understanding of the Basic Law in a lively and interactive manner through promotional activities at the district level, such as roving exhibitions and variety shows; and

Reply :

The Chief Executive announced in the 2007-08 Policy Address that the HKSAR will take early action in supporting the preparation of the National 12th Five-Year Plan under the principle of "One Country, Two Systems". The aim is to enable us to make more timely and effective contributions to the development of our country, and for Hong Kong to leverage on the latest developments of the Mainland to set the stage for our long-term development. As part of the early preparatory work, efforts will be made in 2008-09 to enhance liaison and communication between the concerned bureaux/departments of the HKSARG and their Mainland counterparts through mutual visits and meetings etc. The HKSARG may also need to conduct research and studies on selected topics. The resources required for us to assist in taking forward this new initiative in 2008-09 will be absorbed within the operating expenditure envelope under Head 144.

2. World Expo 2010 Shanghai will provide an excellent opportunity for us to publicise Hong Kong as a city of quality living and creativity. The HKSAR Government intends to take part in the event and construct a stand-alone Hong Kong Pavilion in Shanghai. Apart from this, the HKSAR Government also intends to participate in a full range of related activities, including the Urban Best Practices Area exhibition, World Expo seminars, Internet World Expo, Hong Kong Week, parades and cultural performances. At the initial stage, we will create one time-limited post each of Chief Executive Officer and Architect to support the project. We have also earmarked \$69 million (at September 2007 prices) for designing and constructing the Hong Kong Pavilion. Apart from these costs, additional expenditure will also be incurred for various exhibitions and related activities such as the software component and running cost of the Hong Kong Pavilion, performances and ancillary events. The exact financial

implications are being assessed and the necessary funding approval by LegCo will be sought in due course.

He will normally attend regular meetings of the relevant LegCo panel, as assigned by the Secretary.

3. The Political Assistant is mainly responsible for providing political support and input to Secretary, and to conduct the necessary political liaison on the instruction of the latter.

4. The duties for the Under Secretary and Political Assistant are different from the functions of Government Information Services, which is responsible for publicising and promoting the policies, actions and services of the Government to the public in Hong Kong and the wider community abroad.

5. The provision for salary and general departmental expenses arising from the creation of the positions of Under Secretary and Political Assistant in 2008-09 is about \$5.5 million.

The increased provision for 2008-09 under Programme 1 is mainly due to the salary and general departmental expenses arising from the creation of one position each of Under Secretary and Political Assistant as well as a post of Senior Personal Secretary.

2. For Programme 2, the increased provision is mainly for enhancing promotion of the Basic Law, preparing HKSAR's participation in the Expo Shanghai 2010, complementing the Nation's 12th Five-Year Plan, conducting public consultation on the two electoral methods for 2012 and the creation of new posts to strengthen support for these initiatives.

3. In 2008-09, the estimate for Programme 5 is \$112.6 million. This is in fact 2.6% higher than the revised estimate for 2007-08. Of this figure, we have proposed to allocate \$39.1 million to the Office of the Privacy Commissioner for Personal Data (PCPD), representing an increase of \$2.8 million (7.7%) over that of 2007-08, for stepping up enforcement of the Personal Data (Privacy) Ordinance (PDPO) and organising programmes to enhance public awareness of personal data protection. The increased financial provision includes \$1 million for PCPD to step up publicity and education programmes in 2008-09.

4. We are also conducting a comprehensive review of the PDPO jointly with PCPD to examine, among other things, whether the existing provisions of the Ordinance still afford adequate protection to personal data having regard to developments, including advancement in technology, in the last decade.

The Registration and Electoral Office (“REO”) monitors the conduct of exit polls in accordance with the relevant Guidelines on Election-related Activities (“Guidelines”). Under the existing Guidelines:

- (a) a list of the persons or organisations allowed to conduct exit polls will be made available to the public prior to the polling day for reference by the public and the candidates. The list will also be displayed at the concerned polling stations; and
- (b) interviewers are required to wear a badge bearing the name of the organisation allowed to conduct the exit poll. Any interviewers not wearing the said badges will not be allowed to conduct the exit poll.

2. In light of experience gained in the 2007 District Council Election and the Legislative Council Hong Kong Island Geographical Constituency By-election, the Electoral Affairs Commission (“EAC”) has recommended that:

- (a) the exit poll interviewers should be reminded that they must wear their identification badges issued by the REO;
- (b) the REO should make use of appropriate publicity channels to remind electors that the exit polls are neither conducted by the EAC nor the Government; and

Publicity measures include television and radio announcements of public interest, posters and outdoor giant banners, lamppost buntings, public transport advertisements, roving exhibitions, bus parades, television and radio programmes, websites and pamphlets.

We do gauge the effectiveness of the various publicity measures when an election publicity campaign is launched. Through the publicity campaign,

144 837 new voters were registered and 288 351 registered voters updated their registration information in 2007-08. Besides, the increase in the number of DC election candidates from 837 in 2003 to 907 in 2007, together with the upsurge in the number of voters from 1.06 million in 2003 to 1.14 million in 2007 proved that public participation in elections has been enhanced.

Reply :

The major duties of these 35 non-directorate posts are to assist in the preparation and conduct of the 2008 Legislative Council Election, including:-

- (i) to prepare proposed amendments to the subsidiary legislation on electoral procedures;
- (ii) to conduct the 2008 voter registration exercise;
- (iii) to arrange publicity activities for the election;
- (iv) to review and prepare proposed revisions to the electoral guidelines, conduct public consultation on the revised guidelines, and issue the updated guidelines;
- (v) to handle election-related complaints; and
- (vi) to plan and make detailed logistical arrangements for the conduct of the election.

2. These 35 non-directorate posts are time-limited posts created with provision given for a specified period and are scheduled to be deleted in 2008-09. The provision for these time-limited posts is about \$17 million. These posts will be deleted in phases from late 2008 to early 2009.

The suggested improvements cover areas relating to preparation work and operational arrangement on the polling day. In addition, the EAC also made recommendations relating to the Guidelines on Election-related Activities in respect of the LegCo Elections ("Guidelines").

2. The Government will work closely with the EAC to follow up on the recommendations contained in the reports, taking into consideration the views of the community. Question :

The Administration estimates that it will require more than \$62.7 million for Hong Kong to participate in the World Exposition 2010 Shanghai China. The project is expected to commence in the third quarter of 2008-09, but the estimated expenditure in 2008-09 is only \$1 million, which might affect its commencement and progress.

- (1) Is it true that the Administration has allocated only \$1 million as the prize for the winner of the Hong Kong pavilion conceptual design competition?
- (2) If "yes" for (1), the sum might be too small to attract top professionals in construction, planning and design sectors to take part in the competition. Will the Administration consider duly increasing the amount of the prize? If "no" for (1), will the Administration consider duly increasing the amount of the estimated expenditure so as to expedite the commencement and progress of the project?
- (3) Please list out the items, human resources and expenditure allocation that will be involved in the project.

Reply :

- (1) We plan to adopt a design-and-build approach for implementation of the Hong Kong Pavilion project. The estimated expenditure of the project in 2008-09 is to meet the cost of design work including obtaining approvals from Mainland authorities during the initial contract period. It is not for the prize for the winner of the Hong Kong Pavilion concept design competition.

- (2) The aim of the concept design competition is to enable us to tap the best creative ideas of local professionals. The awards for the competition were determined having regard to factors such as the arrangements for similar competitions in the past and the views of the relevant professional body. The winning design is intended to serve as a design reference for the Design-and-Build Contractor of the Hong Kong Pavilion. As design work and approval by Mainland authorities are the key activities during the initial contract period in 2008-09, we anticipate that the project expenditure in 2008-09 will not be too high. Should the design and related planning work progress well for an early start of the construction works, we will increase the project expenditure in 2008-09 accordingly.
- (3) The preparatory work for HKSAR's participation in World Exposition 2010 Shanghai China is still in progress. Relevant details are being consolidated. We anticipate that more detailed information will be available by the time the funding proposals are submitted to the Public Works Subcommittee and Finance Committee.
