The Administration is also requested to provide details on the increase in the scope and volume of work to be undertaken by the Taiwan Office as a result of the increase in financial provision in the next financial year.

Regarding the Beijing Office (BJO), the Hong Kong Economic and Trade Offices (ETOs) in Guangdong, Shanghai, Chengdu and Wuhan, and the Hong Kong Economic, Trade and Cultural Office (HKETCO) in Taiwan (Mainland and Taiwan Offices), the revised estimated expenditure for 2013-14, the estimated expenditure for 2014-15 and the percentage increase are set out in the table below:

- 2. As a whole, the estimated expenditure of the Mainland and Taiwan Offices for 2014-15 is \$46 million higher than the revised estimated expenditure for 2013-14, representing an increase of 22.4%. The increased provision is mainly used for setting up a new ETO in Wuhan, the subsequent establishment of a liaison unit in the Northern Region of the Mainland, followed by another one in the Eastern Region, and the full-year provision required for continuing to enhance the functions of the Mainland Offices.
- 3. The estimated expenditure of the HKETCO for 2014-15 is broadly similar to the revised estimated expenditure for 2013-14. In 2014-15, the Office will continue to:
 - (a) establish and maintain contacts with various sectors, cities and municipalities, and relevant authorities in Taiwan to foster closer economic, cultural and other co-operation and exchanges between Hong Kong and Taiwan;
 - (b) facilitate Hong Kong businesses in tapping business opportunities in Taiwan while encouraging Taiwanese businesses to invest in Hong Kong;
 - (c) organise and support promotional and cultural events to publicise Hong Kong in Taiwan; and
 - (d) assist the Hong Kong-Taiwan Economic and Cultural Cooperation and Promotion Council in organising meetings and activities to further enhance exchanges with Taiwan.

Reply:

Under the "One Country, Two Systems" principle, the Hong Kong Special Administrative Region (HKSAR) Government has commenced the groundwork to complement the drafting of the National 13th Five-Year Plan. The Steering Committee on Co-operation with the Mainland chaired by the Chief Secretary for Administration has all along been providing the steer and co-ordinating the efforts of relevant policy bureaux and departments in complementing the drafting of the National 13th Five-Year Plan. The work involved is carried out by relevant bureaux and departments with existing manpower and resources.

2. At this stage, bureaux and departments concerned are consulting the relevant sectors and advisory committees to solicit their views on the initially proposed topics. The proposed topics should be strategic topics conducive to the overall development of Hong Kong and the State. These include offshore Renminbi business centre (including asset management and risk management), liberalisation of trade in services, development of maritime and cruise industries,

legal services and dispute resolution services, technology and cultural and creative industries, air quality in the Pearl River Delta Region, etc.

3. A number of regional co-operation platforms with the Mainland provinces and municipalities have been established to promote closer exchanges and co-operation in various aspects between the HKSAR and the Mainland. Copies of full text of the co-operation agreements signed between the governments of the HKSAR and the Mainland at meetings of these co-operation platforms are set out in the press releases issued after the meetings, and are uploaded onto the website of the Constitutional and Mainland Affairs Bureau (http://www.cmab.gov.hk/).

2. Complainants of cases which could not reach settlement, could apply for legal assistance from the EOC or take civil action on their own, according to concerned circumstances. In 2011-12, the EOC granted legal assistance in respect of 21 cases, including 10 cases under SDO, 10 cases under DDO and 1 case under FSDO. In 2012-13, the EOC granted legal assistance in respect of 14 cases, including 5 cases under SDO and 9 cases under DDO. In 2013-14 (as at end of February 2014), the EOC granted legal assistance in respect of 15 cases, including 4 cases under SDO, 10 cases under DDO and 1 case under RDO. These cases arose from previous cases of unsuccessful conciliation, some of which covered conciliation cases in the respective years and some covered cases which arose previously. Most of these cases are on-going and not yet concluded.
