Question:

The Equal Opportunities Commission (EOC) conducted public consultation on the discrimination law review. The EOC's proposals relate to a wide range of defects in all four discrimination ordinances, including the absence of a provision in the Race Discrimination Ordinance prohibiting discrimination by the government in performing its functions and exercising its powers, and the lack of an express statement in the Disability Discrimination Ordinance providing for the requirement to make reasonable accommodation. In this connection, will the government inform this Council of:

- (a) Whether the government has allocated any extra resources to the EOC for conducting this law review and the public consultation in particular and if yes, the details of the funding including the amounts to be spent in different aspects and the period it covers;
- (b) The amounts the EOC has spent and plans to spend on different aspects including publication and promotion, the compilation and analysis of responses from the public, and the publication of reports on the responses from the public; and
- (c) When the EOC will publish a quantitative report and a qualitative report on the responses of the public to the consultation held on the law review in 2014?

Reply:

According to the information provided by the Equal Opportunities Commission (EOC), the public consultation on the Discrimination Law Review ended last year and a very large number of responses (approximately 122 000 responses) have been received. The EOC is now analysing and recording the responses, and the analysis is both quantitative

and qualitative; the EOC has initially planned to publish a factual report on the consultation responses in mid 2015. For details, please refer to the EOC's paper (Paper No. CB(2)995/14-15(05)) submitted to the Legislative Council Panel on Constitutional Affairs.

2. The EOC's work on this review exercise is absorbed by its internal resources.

Reply:

During the period from January 2012 to September 2014, a total of 227 requests for information made under the Code on Access to Information (the Code) were refused by bureaux and departments. The bureaux/departments involved and statistical data on reasons for refusal are as follows:

- 2. During the period from January 2012 to September 2014, a total of 35 requests for review were received by bureaux and departments. In the same period, The Ombudsman received 181 complaints in relation to requests for information.
- 3. We are planning to revamp the Code on Access to Information Website in 2015-16 to include, inter alia, quarterly statistics on requests for information handled by bureaux/departments, such as the outcome of requests handled in the quarter and the exemption provisions under which information requests are refused.

Question:

Pursuant to paragraph 5 of reply no. CMAB067, the Government is requested to provide information on the number of random checks on mobile applications conducted by the Office of the Privacy Commissioner for Personal Data (PCPD) since 2013-14 and the number of breaches of the Personal Data (Privacy) Ordinance that has been found. The Government is also requested to provide the estimated number of such random checks to be conducted in 2015-16.

The Government is requested to provide information on whether the PCPD will assist government departments with the upgrade of their websites to ensure that personal data is properly protected.

Reply:

In 2013-14 and 2014-15, the Office of the Privacy Commissioner for Personal Data (PCPD) conducted compliance checks on 25 mobile applications to ascertain whether they complied with the requirements of the Personal Data (Privacy) Ordinance (the Ordinance). Two cases of incompliance were found, including one contravention of the Data Collection Principle and one contravention of the Data Security Principle.

- 2. In 2015-16, the PCPD will conduct compliance checks on 30 mobile applications.
- 3. The advice on proper protection of personal data which the PCPD provides through guidance notes, information leaflets, professional workshops and seminars to various organisations in Hong Kong including government bureaux and departments is applicable to online operations of public organisations.
