Reply :

In 2003–04 and 2004–05, CAB has continued to coordinate liaison with Taiwan organizations in Hong Kong. Major matters handled through the communication channel between CAB and Taiwan organizations in Hong Kong include –

2003-04

- (a) exchange of information during SARS outbreak;
- (b) arrangement of a chartered flight to Taipei to bring back a Hong Kong tour group with one suspected SARS case;
- (c) assistance in the rescue operation where a group of Hong Kong fishermen in distress near Dongsha Qundao were safely brought home through coordination of the Maritime Rescue Cooperation Centre; and
- (d) relaying information on the Avian Influenza attack in Taiwan.

2004-05

- (a) timely assistance to the injured Hong Kong people involved in a serious

traffic accident in Jiu-fen, Taiwan; and

- (b) assistance in the rescue operation where a group of Hong Kong fishermen in distress in Keelung Harbour, Taiwan due to typhoon attack were rescued .

2. Apart from the above, we facilitated visits by Taiwan's business sector and journalists from Taiwan's newspapers/electronic media. We arranged meetings with government bureaux/departments and visits to major infrastructural projects in Hong Kong. We also met other Taiwan visitors and briefed them on the latest developments in Hong Kong and the implementation on the "One Country, Two Systems" here.

3. There have been frequent liaison with Taiwan organisations in Hong Kong through telephone calls and meetings. Existing resources have been deployed to implement the work involved.

4. In 2005-06, we will continue to coordinate liaison with Taiwan organizations in Hong Kong. Our work programme include –

- (a) liaising with Taiwan organizations in Hong Kong;
- (b) advising and assisting other bureaux and departments on cultural, trade and economic exchanges with Taiwan; and
- (c) where appropriate, briefing Taiwan visitors to Hong Kong on the latest developments in Hong Kong and the implementation of "One Country, Two Systems".

Question : As regards the “9+2” projects undertaken by the Constitutional Affairs Bureau, please provide information on the nature and number of projects included in the revised estimate for 2004-05 and the estimate for 2005-06. Please also specify their respective expenditures.

Reply :

Since the first “Pan-PRD Regional Cooperation and Development Forum” and the signing of the “Pan-PRD Regional Cooperation Framework Agreement” by the Pan-PRD (“9+2”) governments in June 2004, the “9+2” governments have each set up their own “9+2” General Coordination Office to take forward the initiative. The “9+2” General Coordination Office for Hong Kong is set up under the Constitutional Affairs Bureau (CAB), which undertakes general liaison with the “9+2” partners and coordination with relevant bureaux and departments within the HKSAR government.

2. The revised estimate for 2004-05 in respect of work relating to “9+2” is \$1.523 million. The expenditure mainly covered the Opening Ceremony of the First Pan-PRD Regional Cooperation and Development Forum held on 1 June 2004 in Hong Kong, two Pan-PRD Secretary-General meetings held in July 2004 and January 2005 in Sichuan, and five study visits respectively to Hainan, Jiangxi, Sichuan, Fujian and Hunan provinces organised between December 2004 and March 2005. We also participated in a number of activities related to Pan-PRD regional cooperation including the First Pan-PRD Trade Fair held between 14-17 July 2004 in Guangzhou, the Pan-PRD Provincial Capital City Mayors' Forum held on 15-16 September 2004 in Guangzhou, as well as the meeting of the Hong Kong-Guangdong Expert Group on the Promotion of Pan-PRD Cooperation held on 31 January 2005 in Shenzhen.

3. The estimate for 2005-06 is \$2.2 million. Major expenditure items include those related to an incoming visit of representatives from the “9+2” General Coordination Offices in April 2005, and participation in the Second Pan-PRD Regional Cooperation and Development Forum cum Trade Fair to be held in Sichuan in July 2005. It is expected that in 2005-06 we will need to attend more preparatory or working group meetings on “9+2” related issues. We will also continue to conduct study visits to the “9+2” region.

Reply :

The review of the roles, functions and composition of the District Councils (DCs) is expected to commence by the end of this year. The Constitutional Affairs Bureau and the Home Affairs Department have set up a working group to make preparations.

2.     When the review commences, we will issue a consultation document to seek the views of DCs and different sectors of the community. In conducting the review, we will have regard to the relevant statutory provisions, the original thinking behind the introduction of the district administration scheme, the recommendations put forth by the Government in the Report of the Working Group on District Councils Review published in 2001, and the experience of the operation of the DCs.

3.     The Bureau will conduct the review with existing resources and will work closely with the Home Affairs Bureau and other relevant bureaux and departments in the process.

Broadly speaking, the official functions attended by the Secretary for Constitutional Affairs (SCA) in the three years referred to in the question include meetings of the Legislative Council (and its committees/panels) and District Councils (DCs), local and overseas media interviews, meetings with Mainland and foreign dignitaries, district visits, seminars and forums on constitutional development and other issues organised by the government and outside organisations, as well as functions organised by academic institutions and political and community organisations. We do not have any readily available information in the form as requested by the Honourable Member.

2.        However, in the last four months, SCA attended, for example:

- (a)        about 20 meetings with District Councils;
- (b)        over 25 media interviews or programmes; and
- (c)        some 20 seminars and forums on constitutional development and other issues.

3. We expect that the momentum of these engagements will continue in future, because the fifth report of the Task Force is expected to be published later in the year and the DC review will start before end 2005.

Question : Has the Government earmarked any provision in the estimate for 2005-06 for addressing the issue of constitutional development after 2007? If so, please provide details of the estimated expenditure and the work plan respectively.

Asked by : Hon. LEUNG Kwok-hung

Reply :

In the 2005-06 financial year, a provision of \$1.5M has been earmarked for work relating to constitutional development. The provision is mainly for publication of reports, public consultation and publicity activities, and other miscellaneous expenses. In addition, 1 Administrative Officer and 2 supporting staff will be redeployed within the CAB, and 6 additional staff will be temporarily redeployed from other departments, to support the Constitutional Development Task Force Secretariat.

2. Public consultation on the Fourth Report of the Constitutional Development Task Force is continuing and will end on 31 May 2005. The Task Force aims to publish its Fifth Report in the latter half of this year after consultation with the newly elected Chief Executive. It aims to put forth a mainstream proposal to facilitate public discussion, and we hope to gain the support of the public and the legislature.

3. Details of the activities and the estimated expenditure will depend on the progress and requirement of the work of the Task Force.

Reply :

On electoral matters, the Constitutional Affairs Bureau (CAB) is responsible for formulating policies and, as necessary, the enactment of primary legislation. For the upcoming Chief Executive (CE) election, CAB introduced on 6 April 2005 the Chief Executive Election (Amendment)(Term of Office of the Chief Executive) Bill into the Legislative Council. The Bill aims to clarify that, where the office of the CE becomes vacant under section 4(b) or (c) of the Chief Executive Election Ordinance<sup>Note</sup>, the term of office of the new CE shall be the remainder of the term of the preceding CE. The necessary resources and the expenditure involved in carrying out the work relating to the CE election are absorbed within the resources allocated to the Bureau.

Note    Section 4 of the Chief Executive Election Ordinance provides as follows:  
“4.    The office of the Chief Executive becomes vacant –  
(a)    on the expiry of the term of office of the Chief Executive;  
(b)    if the Chief Executive dies; or  
(c)    if the Central People’s Government removes the Chief Executive from office in accordance with the Basic Law.”

2. The Electoral Affairs Commission (EAC) has the statutory responsibility for the conduct and supervision of elections. The Registration and Electoral Office will provide the EAC with the necessary support in conducting the CE election and the Election Committee sub-sector by-elections.

Similar visit programmes for visitors from the Mainland, Macao, and Taiwan will also continue to be organized.

3. - (ii) assistance in the rescue operation where a group of Hong Kong fishermen in distress in Keelung Harbour, Taiwan due to typhoon attack were rescued.

Apart from the above, we facilitated visits by journalists from Taiwan's newspapers/electronic media and visitors from other sectors. We arranged meetings with government bureaux/departments and visits to major infrastructural projects in Hong Kong. We also briefed them on the latest developments in Hong Kong and the implementation of the "One Country, Two Systems" here.

There have been frequent liaison with Taiwan organisations in Hong Kong through telephone calls and meetings. Existing resources have been deployed to implement the work involved.

These projects include Basic Law seminars, publication of the Basic Law Bulletin, the "Basic Law Promotion Day" Competition, production of TV announcements in the public interest, a Basic Law speech contest, introduction of a Basic Law webgame, the civic education teacher development programme, production of posters for schools on National and Special Administrative Regional Emblems, "Journey to China Study Tour Project", flag-raising training for students, Basic Law teleline stories and a Basic Law interactive drama series.

The relevant bureaux and departments allocated a total of 4 million in 2004-05 to organize the above activities, of which the Constitutional Affairs Bureau contributed \$2.215 million.

Many of these promotional activities aim to promote the Basic Law in general. For example, we have in 2004-05 launched the TV announcements in the public interest entitled “One Country, Two Systems” to promote public understanding of such basic principles as “One Country, Two Systems”, “a high degree of autonomy” and “Hong Kong people ruling Hong Kong”. The Basic Law speech contest and the Basic Law quiz and talent competition covered various chapters of the Basic Law and aimed to promote the Basic Law in general. Some of the events focused on specific issues in the Basic Law and related provisions, for instance, seminars on “The Basic Law and the Legal System of the HKSAR”.

- (2) In 2005-06, the relevant bureaux and departments have allocated a total of about \$7.6 million for promoting the Basic Law, in which \$5 million is contributed by the Constitutional Affairs Bureau (CAB) for the purpose of stepping up Basic Law promotion in the 15th anniversary of its promulgation. As in previous years, we would make use of a variety of channels to promote public awareness and understanding of the Basic Law. - (i) the production of four reports of the Constitutional Development Task Force (\$0.661M);
- (ii) public consultation events and publicity activities, including briefings, seminars, regional forums, focus groups, open forums, APIs and a dedicated website (\$0.916M);
- (iii) other expenses, including postage, temporary staff, stationery and other office miscellaneous items (\$0.968M).

3. In addition, 1 Administrative Officer and 2 supporting staff were redeployed within CAB, and 6 additional staff were temporarily redeployed from other departments, to support the Task Force Secretariat.



4. Policy input on matters relating to constitutional development after 2007 was provided by existing resources in CAB.

5. During the public consultation for the various reports of the Task Force, many valuable views and proposals were received. A total of about 1,600 participants attended the seminars, forums and discussion groups on the Third and Fourth Report. More than 2,000 written submissions were received by the Task Force on various reports released so far. In addition, the total page views of the constitutional development website since its launch on 19 February 2004 is over 1.4 million.

6. Public consultation on the Fourth Report of the Task Force is continuing and will end on 31 May 2005. The Task Force aims to publish its Fifth Report in the latter half of this year after consultation with the newly elected Chief Executive. Its aims to put forth a mainstream proposal to facilitate public discussion, and to gain the support of the public and the legislature.

#### *Implementation of “One Country, Two Systems” principle*

7. Since reunification, the Constitutional Affairs Bureau has been keeping an overview of the implementation of the “One Country, Two Systems” principle in Hong Kong Special Administrative Region (HKSAR) and has been providing advice to bureaux and departments in this respect.

8. In 2004-05, we demonstrated to visitors from abroad the successful implementation of the “One Country, Two Systems” principle, and continued to introduce the latest development in Hong Kong through visits to Government bureaux and departments. Similar visit programmes were also organized for visitors from the Mainland, Macao and Taiwan. We had more than 3,200 official exchanges with Mainland and Macao government officials in 2004. Through these exchanges, we presented to the visitors first hand information regarding the successful implementation of the “One Country, Two Systems” principle.

9. We also made use of briefings by HKSAR’s overseas Economic and Trade Office, take the opportunities of overseas visits by senior Government officials, as well as through HKSAR’s participation in international fora, to widely publicize abroad the successful implementation of the “One Country, Two Systems” principle and the Basic Law in the HKSAR. Countries visited by the Chief Secretary for Administration and other senior government officials in 2004-05 include the United States of America, Canada, the United Kingdom, Germany, France, Sweden, Mexico, Chile, Japan, Thailand and India. HKSARG participated in over 140 international conferences in 2004.

10. We also promoted the successful implementation of the “One Country, Two Systems” principle to the local and international communities through the distribution of publications on the implementation of the Basic Law. For instance,

we distributed the “Hong Kong and its Basic Law” pamphlet to overseas communities through the Economic and Trade Offices. The Basic Law leaflet was also distributed to overseas participants taking part in a number of international conferences held in Hong Kong.

11. The above work was carried out in 2004-05 by existing resources. We will continue to do the above work with existing resources in 2005-06.

The grades of the 45 permanent posts in Constitutional Affairs Bureau is at **Annex.**

2. During the 2004-05 financial year, the Constitutional Affairs Bureau (CAB) provided support to the work of the Constitutional Development Task Force (Task Force). A dedicated team was set up within the Bureau to serve as its secretariat. CAB was also responsible for policy and practical work relating to constitutional development after 2007.

3. Among the 45 permanent posts, 1 Administrative Officer and 2 supporting staff have been redeployed within the Bureau to support the Task Force Secretariat. (In addition, 6 additional staff were temporarily redeployed from other departments to support the Task Force Secretariat.) Policy input on matters relating to constitutional development after 2007 was also provided by CAB with existing resources, which included 1 Administrative Officer Staff Grade C, 1 Senior Administrative Officer and 2 supporting staff.

4. During the public consultation for the various reports of the Task Force, many valuable views and proposals were received. A total of about 1,600 participants attended the seminars, forums and discussion groups on the Third and Fourth Report. More than 2,000 written submissions were received by the Task Force on various reports released so far. In addition, the total page views of the

constitutional development website since its launch on 19 February 2004 is over 1.4 million.

5. Public consultation on the Fourth Report of the Task Force is continuing and will end on 31 May 2005. The Task Force aims to publish its Fifth Report in the latter half of this year after consultation with the newly elected Chief Executive. It aims to put forth a mainstream proposal to facilitate public discussion, and to gain the support of the public and the legislature.

6. As for the promotion of the Basic Law, 1 Administrative Officer Staff Grade C, 1 Administrative Officer and 1 supporting staff have been deployed to, among other things, provide secretariat support to the Basic Law Promotion Steering Committee, to plan and implement Basic Law promotion activities and coordinate various Basic Law promotion initiatives from relevant bureaux and departments. (These Officers also undertake duties other than the promotion of the Basic Law). In 2004-05, CAB launched 15 promotion activities, attracting over 17,000 participants. These activities include a Basic Law seminar, publication of the Basic Law Bulletin, the “Basic Law Promotion Day” Competition, Basic Law Quiz and Talent Competition, production of TV announcements in the public interest, Basic Law Speech Contest, a Basic Law webgame, student flag-raising event and survey on the public understanding of the Basic Law.

7. In 2000 and 2002, CAB commissioned the Census and Statistics Department to conduct surveys on the public understanding of the Basic Law. The percentage of members of the public aged 15 or above who claimed to have a good or some knowledge of the Basic Law increased from 25% in the first survey to 48% in the second. The percentage of members of the public who claimed to have heard of the Basic Law increased from 80% in 2000 to 90% in 2002. It is clear that the public’s understanding of the Basic Law has been enhanced. Another survey was conducted in 2004. The results are now being analysed.

Reply :

For the Legislative Council and District Council elections, the Registration and Electoral Office is required under the relevant electoral law to send a poll card at least ten days before polling day to each elector notifying him of the date of election, polling hours, the constituency to which he belongs, and the address of the polling station assigned to him. The poll card is sent together with a copy of the relevant candidates' introductory leaflets, a location map of the polling station assigned to the elector concerned, a guide on voting and a leaflet of the Independent Commission Against Corruption. This statutory timeframe has been set having regard to the lead time required, after the close of the nomination period, for the printing and delivery of the various election-related materials mentioned above to over 3.2 million registered electors.

Given the huge amount of election-related materials to be printed and sent to the electors concerned, the work has to be conducted in batches. Our records show that the first batch of election-related materials are normally sent to electors days ahead of the target date, whereas the last batch of election-related materials are sent to electors at least ten days before polling day. We will continue to make best endeavours to send the election-related materials to the electors as soon as possible.

The problems relating to the practical arrangements on polling day resulted in additional expenditure mainly in two areas. First, to address the problem of the shortage of ballot boxes in various polling stations, an additional transportation cost of about \$30,000 was incurred to deliver additional ballot boxes to the polling stations. Secondly, the problem in the compilation of voter turnout statistics due to the failure of the Interactive Voice Response System led to the late announcement of election results for geographical constituencies. As a result, polling and counting staff were required to remain on duty for a longer period than expected. Additional honorarium of about \$7 million was paid to the polling and counting staff for the extra working hours. All the additional expenditure is absorbed by the provision under “(3) Other Expenses” as set out in paragraph 1.

In working out the practical arrangements for the upcoming Election Committee Subsector by-elections and the Chief Executive Election, the Registration and Electoral Office (REO) has taken into account the review conducted by the Electoral Affairs Commission (EAC) on the 2004 Legislative Council election and the recommendations put forth in the EAC reports. In particular, the following measures which can be implemented immediately will be put in place in the upcoming elections:

- (a) arrangements are being drawn up to cater for emergency situations;
- (b) best endeavours have been made to recruit civil servants with experience in conducting elections as polling and counting staff; and
- (c) more senior officers (including the Chief Electoral Officer) will station at the Central Command Centre on polling days to strengthen the command structure.

The estimated expenditure for conducting the Election Committee Subsector by-elections and the Chief Executive Election (i.e. about \$22 million) has included expenditure to be incurred by (a) and (b) above. REO will endeavour to absorb the expenditure from provision reserved for conducting possible by-elections to the Legislative Council and District Councils. Supplementary provision will be sought if and when necessary before the close of the 2005-06 financial year.

REO will continue to review and improve the arrangements for future elections having regard to the longer term improvement measures put forth in the EAC Reports on the 2004 Legislative Council election and the report to be published by the Independent Committee of Experts. Among other things, REO will step up training on polling arrangements, so

that all those who may be involved in managing electoral arrangements will be fully equipped to do so. If the implementation of the improvement measures in future elections require additional resources, supplementary provision will be sought as necessary.
