Question : What measures have been taken by the Constitutional Affairs Bureau (CAB) last year to implement the Enhanced Productivity Programme (EPP)? What was the amount of expenditure thus reduced? What further actions will CAB take in the implementation of EPP in 2001-02? What is the estimated reduction in expenditure?

Reply : The Constitutional Affairs Bureau achieved the 5% EPP savings of \$2 million in full in the 2000-01 financial year by deleting six permanent non-directorate posts. These posts comprise 1 Senior Administrative Officer, 2 Personal Secretary I, 1 Personal Secretary II, 1 Clerical Officer and 1 Confidential Assistant. Although we have not set a target of savings for the 2001-02 financial year, we will continue to explore other measures to make full use of our human resources through process re-engineering and the use of information technology. We will also adopt measures to reduce office expenses on paper, overseas telephone calls, rental of vehicles, stationary, etc.

Question : What were Government's provisions for promoting people's understanding of the Basic Law in, respectively, 1998-1999, 1999-2000 and 2000-2001? And what were the details of programmes launched? Please also provide information on the estimated provision and planned programmes for 2001-2002.

Asked by : Dr Hon YEUNG Sum

Reply : When the Basic Law Promotion Steering Committee (BLPSC) was set up in January 1998, a sum of \$10 million was set aside for the promotion of the Basic Law. In 1998-1999 and 1999-2000, the BLPSC allocated \$5.27 million and \$4.73 million respectively to sponsor various promotional activities organised by government departments and non-governmental organisations. A list of the promotional activities are at Annex A. It should be noted that some of the activities approved by the BLPSC in 1999-2000 were held in 2000-2001 to commemorate the 10th anniversary of the promulgation of the Basic Law. Of the approved allocation of \$4.73 million in 1999-2000, the actual expenditure in 1999-2000 is \$2.93 million and the estimated expenditure in 2000-2001 is \$1.75 million. Subject to verification of the final account, there will be an unspent provision of \$0.05 million.

2. Since the allocation of \$10 million has been fully committed, the BLPSC has decided that from 2000-2001 onwards, government bureaux and departments should absorb the expenditure for the promotion of the Basic Law within their annual departmental expenses. In the 2000-2001 financial year, the relevant bureaux and departments have altogether put aside some \$3.75 million for promoting the Basic Law. A list of the promotional programmes are at Annex B.

3. For 2001-2002, bureaux and departments concerned are now working on the programmes and action plans for the promotion of the Basic Law. These will be funded by their own recurrent expenditure sub-heads. Details of the promotional programmes and their estimated costs are not available yet. For CAB, we will continue to coordinate these efforts and operate the Basic Law Homepage. On top of that, we have been allocated \$5.56 million to launch an intensive publicity campaign in the next two financial years, i.e. 2001-2002 and 2002-2003, to promote understanding of specific provisions of the Basic Law.

Question : What is the amount of provision set aside by the Government for further enhancing our working relationship with the Hong Kong and Macao Affairs Office (HKMAO) of the State Council and the Office of the Commissioner of the Ministry of Foreign Affairs (MFA Office) in 2001-02? What kind of enhancement programmes are planned ?

Reply : Working relationship with the HKMAO

CAB works closely with the HKMAO to cultivate and maintain a constructive working relationship between the HKSAR Government and the Central People's Government (CPG) and other Mainland authorities. We oversee and advise on official exchanges with the CPG and other Mainland authorities.

2. The annual staff cost for the six permanent posts devoted for this and other duties in 2001-02 is \$4 million.

3. In 2001-02, we have set aside \$300,000 to invite Mainland officials at provincial and municipal levels to visit Hong Kong to enhance their understanding of the Hong Kong Special Administrative Region and the "One Country, Two Systems" principle.

Working relationship with the MFA Office

4. CAB keeps an overview of the conduct of the HKSAR's external affairs and assumes an overall coordinating role in managing contacts between the HKSAR Government and the MFA Office. We work closely with the MFA Office on matters relating to the HKSAR's external affairs to ensure full compliance with the Basic Law and to meet the practical needs of the HKSAR.

5. The annual staff cost for the five permanent posts devoted for this and other duties in 2001-02 is \$3.5 million.

6. To further enhance our co-operation and exchanges with the MFA, we have set aside \$115,000 in 2001-02 to invite officials from the MFA in Beijing who deal with matters relating to the HKSAR to visit Hong Kong.

Question : Please advise this Council : -

- (a) what are the details of the intensive publicity campaign to enhance knowledge and understanding of specific provisions of the Basic Law? Please provide a detailed breakdown of the estimated expenditure.
- (b) regarding the survey to gauge the public's understanding of the Basic Law and identify the effective means to better promote the Basic Law, when will it be conducted and when will it be completed?
- (c) please provide a detailed breakdown of the expenditure on the survey.
- (d) what is the estimated cost for implementing improvements proposed in the survey?

Reply : (a) CAB has been allocated a sum of \$5.56 million to launch an intensive publicity campaign in the next two financial years of 2001-2002 and 2002-2003. We plan to spend about \$2.8 million in the first year and we will consider publicizing the Basic Law provisions that are closely related to people's daily lives through various means. The design of promotional programmes will take into account the findings of the survey conducted to gauge the public's understanding of the Basic Law. We will seek to finalise the design of the promotional programmes in the first quarter of 2001-2002. A detailed breakdown of the expected expenditure is therefore not yet available.

- (b) As referred to above, in order to gauge the public's understanding of the Basic Law and to identify the effective means to promote the Basic Law, CAB has, with the assistance of the Census and Statistics Department, commissioned a research firm to conduct a Basic Law opinion survey in the fourth quarter of 2000. The survey report will be available by end of March or early April.
- (c) The cost of the Basic Law opinion survey is \$300,000.
- (d) The Basic Law opinion survey has focussed on four specific target groups i.e. "Local Community", "Teachers", "Students" and "Civil Servants". The Basic Law Promotion Steering Committee will consider the survey's findings when formulating future promotional strategies and plans. As the promotional plans have not yet been formulated, it is not possible to give their estimated costs.

- Question : (a) what are the new channels of communication to be established to facilitate the liaison with the Guangdong Province and what is the amount of expenditure involved?
(b) what are the expected benefits brought by these new channels on facilitating communication?
(c) are there any reviews and evaluations on the effectiveness of the communication and liaison of the past? If yes, what are the details of these reviews and evaluations? If no, why?

Reply : (a) Constitutional Affairs Bureau coordinates communication between the HKSAR Government and the authorities in Guangdong. The communication channels include the Boundary Liaison System which handles operational issues affecting both sides of the boundary, and the Hong Kong/Guangdong Co-operation Joint Conference which provides the forum for regional cooperation with Guangdong Province on major issues such as environmental protection and tourism. Various sub-committees and expert groups have been set up under these channels to discuss and examine specific issues.

We will continue to make use of the existing communication channels to strengthen liaison and cooperation with the Guangdong authorities. Where necessary, we will assist the relevant bureaux/departments to establish new sub-committees or expert groups under these channels to consider specific subjects of mutual concern. The amount of expenditure can only be assessed as and when these sub-committees and expert groups are established. It is envisaged that expenditure in this regard will be absorbed by the relevant Bureaux/Departments.

(b) The setting up of sub-committees or expert groups will enable the relevant Bureaux/Departments of the HKSAR Government and the Guangdong authorities to conduct in-depth studies of specific problems or cooperation proposals. It will also enhance mutual understanding and cooperation.

(c) The effectiveness of the existing communication channels is kept under review from time to time. In particular, both sides would review and evaluate the effectiveness of the liaison channels in the annual boundary liaison meetings and the plenary sessions of the Hong Kong/Guangdong Cooperation Joint Conference. We consider that the present channels have been functioning satisfactorily.

Question : As regards the study on the feasibility of using more technology to improve our electoral arrangements, please advise this Council:

- (a) What are the details of the work and expenditure involved in 2001-02?
- (b) When will the feasibility study be expected to complete?
- (c) Will the Government consult the public on the recommendations of the feasibility study? If yes, what are the details of the consultation? If no, why?

Reply : (a) The feasibility study will look at the technical viability of developing a new Electoral and Registration system (EARS) to facilitate the maintenance and management of electoral records by the Registration and Electoral Office. Subject to the recommended option being accepted by the Administration, we will seek the funding approval of the Finance Committee to proceed with detailed system design and implementation. We have earmarked \$65 million for the project under Capital Works Reserve Fund Head 710 Computerisation and the expected expenditure for 2001-02 is \$2 million. In addition to developing a new EARS, the study will also look at the feasibility of wider application of information technology in electoral services. We will consider the study results before deciding whether the recommendations should be implemented.

- (b) The study is expected to be completed within the first half of 2001.
- (c) We will consult Members of the Legislative Council Panel on Constitutional Affairs on the recommendations of the feasibility study in due course.

Question :

In respect of further enhancement of our working relationship with the Hong Kong and Macao Affairs Office (HKMAO) of the State Council and the Office of the Commissioner of the Ministry of Foreign Affairs in HKSAR (MFA Office), how many official exchanges between CAB and HKMAO and MFA Office were organized in 1999 and 2000 respectively? What is the topic of discussion of the respective exchanges?

Reply :

CAB works closely with HKMAO to cultivate and maintain a constructive working relationship between the HKSAR Government and the Central People's Government (CPG) and other Mainland authorities. Official exchanges take the form of discussions over the telephone, correspondence and meetings. In 1999 and 2000, in addition to exchanges by correspondence or over the telephone, we had 7 meetings with HKMAO. Subjects discussed included the following broad areas :

- (a) working relationship between the HKSARG and the CPG;
- (b) liaison channels between bureaux and departments of the HKSARG and their counterparts in the Mainland;
- (c) cooperation between Hong Kong and Guangdong;

- (d) mechanism for amending the Basic Law;
- (e) matters relating to “Home Visit Permits”;
- (f) referral mechanism of cases of Hong Kong residents in distress in the Mainland;
- (g) visits to HKSAR by CPG and provincial/municipal officials;
- (h) exhibition on the 50th anniversary of the establishment of the PRC.

2. CAB also works closely with the MFA Office in Hong Kong. The subjects of official exchanges include matters relating to -

- (a) the negotiation and conclusion of international agreements between HKSAR and foreign governments;
- (b) HKSAR’s participation in international organizations and conferences;
- (c) the establishment of consular missions and other consular matters;
- (d) the implementation of the PRC’s international obligations applicable to HKSAR; and
- (e) the application to HKSAR of international agreements to which PRC is or will become a party.

Official exchanges take the form of meetings, discussions over the telephone and correspondence. We do not keep statistics of our official exchanges with the MFA Office but such exchanges occur frequently.

The channels of communication between the HKSAR Government and the authorities in Guangdong coordinated by CAB include the Boundary Liaison System which handles operational issues affecting both sides of the boundary and the Hong Kong/Guangdong Co-operation Joint Conference which provides the forum for regional cooperation with Guangdong Province on major issues such as environmental protection and tourism. Various sub-committees and expert groups have been set up under these communication channels to discuss and examine specific issues.

Reply :

The plenary session of the Hong Kong/Guangdong Cooperation Joint Conference (Joint Conference) met on 25 September 2000. Under the Joint Conference there are over 10 expert or ad hoc groups formed by the relevant bureaux and departments and their Guangdong counterparts working in different areas of cooperation. These groups met formally and informally on many occasions in 2000-01. At the plenary session in September 2000, both sides agreed on a number of long-term co-operation initiatives, such as in the area of environmental protection. The meeting also reported substantive progress made in the area of tourism, extending operating hours of Shenzhen/Shekou passenger crossing, implementing a joint cheque clearance system between Hong Kong and Guangdong, the language teacher exchange programme and linking up information networks between the government departments on both sides.

2. For CAB, the staff and other costs for coordinating the plenary session of the Joint Conference in September 2000 were minimal. The staff and other costs in respect of the expert or ad hoc groups formed under the Joint Conference are borne by the relevant bureaux and departments.

Question : The Basic Law provides that, as an ultimate aim, the Chief Executive and all Members of the Legislative Council shall be elected through universal suffrage. What is the measure that the Constitutional Affairs Bureau will put in place for the 2001-02 financial year pursuant to the Basic Law requirement?

Reply : The Basic Law (BL) provides that the method for the selection of the Chief Executive (CE) and for the formation of the Legislative Council (LegCo) shall be specified in the light of the actual situation and in accordance with the principle of gradual and orderly progress (BL 45 and 68). While universal suffrage is the ultimate aim, the BL provides that, in the meantime, the CE shall be elected in accordance with the method prescribed in Annex I (BL 45) and the LegCo, Annex II (BL 68).

For the 2001-02 financial year, our task is to introduce a Chief Executive Election Bill into LegCo to provide the legal framework for the election of the CE in accordance with the principles laid down in the BL and the specific method of election set out in BL Annex I. In respect of LegCo, we are undertaking a study on the government systems practised in selected countries, with a view to developing a system that best suits Hong Kong's long-term interests.

2. We have reported to the LegCo CA Panel our discussion with HKMAO on the matter.
