Question : At the request of Hon Emily LAU, Chairman of the Finance Committee, the Administration agrees to provide information on the detailed breakdown of the \$1.5 million reserved for conducting the public consultation on the roadmap for implementing universal suffrage.

Asked by : Hon. LAU Wai-hing, Emily

Reply :

When preparing the draft Estimates, our cardinal consideration is to seek a provision not greater than is necessary for delivering the concrete tasks envisaged. Otherwise, we would be depriving the community of much needed funds for pursuing other equally deserving public policies and services.

Discussions at the Commission on Strategic Development (CSD) clearly indicate that the process in search of a consensus on the implementation of universal suffrage is interactive. The contents of the report to summarize the discussions of the CSD and the detailed plans for public consultation on the report are, therefore, evolving. Our current plan is to publish the report in around mid-2007. For budget planning purpose, at this stage, we have set aside \$1.5 million. The estimated provision covers the following items:

The above estimate covers expenditure directly related to the public consultation exercise. The provision does not cover staff costs, as these would be absorbed from within the existing resources of the Constitutional Affairs Bureau.

We would like to emphasize that the \$1.5 million earmarked represents a prudent approach to budgeting. Subject to established rules, policy bureaux have flexibility to redeploy funds within their allocation. The HKSAR Government attaches great importance to narrowing the differences in views on the models of universal suffrage, and if discussions at CSD suggest that the public consultation exercise needs to involve expenditure items beyond those envisaged, the Constitutional Affairs Bureau will redeploy resources within its own allocation to ensure that the exercise will be conducted in a proper and wholesome manner.
