Sexual Minorities Forum

Issues relating to Membership of the Sexual Minorities Forum

Purpose

In response to members' concerns over the participation of New Creation Association (NCA) in the Sexual Minorities Forum, this paper sets out the consideration of membership applications to facilitate members' discussion of this issue.

Background

- 2. The Sexual Minorities Forum (Forum) was set up by Home Affairs Bureau (HAB) in September 2004 to provide a channel for non-governmental organizations and the Government to exchange views on issues concerning sexual minorities in Hong Kong.
- 3. The objective of the Forum is to promote equal opportunities for people of different sexual orientation and gender identity. Membership list of the Forum is at **Annex A**.
- 4. Any organization can apply for membership of the Forum at any time. Each application will be assessed by the Chairman of the Forum based on the criteria outlined in paragraph 5.

- 5. In deciding the membership of the Forum, we adhere to the principles of openness and fairness. In addition, each applicant will be assessed on the relevance of its work to the promotion of equal opportunities for people of different sexual orientation and gender identity and has to fulfil at least one of the following requirements -
 - (a) it is a sexual minority or transgender group, or
 - (b) it provides services to sexual minority or transgender community.
- 6. NCA made the application for membership in November 2005. The application was approved because it provided services to sexual minorities in compliance with the relevant requirement.
- 7. At the fifth meeting of the Forum on 13 February 2006, some members opined that NCA's presence might adversely affect discussions at the Forum and suggested to review NCA's participation in the Forum and discuss the issue at the next meeting.
